For stubborn or heavy contamination apply extra material to the cloth and rub the appropriate area firmly.

Finally, buff the surface to a bright finish with a clean dry cloth.

For exceptionally heavy contamination Bond It PVCu SOLVENT CLEANER may be used.

Supplied in 1L plastic bottles.

Colour

Off-white cream/liquid.

Shelf Life

24 months from date of manufacture when stored in unopened bottles.

Storage Conditions

Non-flammable, store upright, in cool conditions. Protect from frost.
