Description:

A high performance inhibitor against formation of scale, rust corrosion, hydrogen gassing, microbiological growth and boiler noise.

Uses

PC100 INHIBITOR is suitable for all metals including aluminium. Once added **PC100** does not need to be replaced unless the system is drained down.

Application

Filling the system: Open systems should be dosed via the filling and expansion tank. If system is full, draining at a low point should be carried out to ensure product enters the circulatory system. Sealed systems should be filled via filling loop or a drained radiator.

Dosage: **PC100** for optimum efficiency should be dosed @1.4% of system volume i.e. 1L per 70L of system water. Generally 1 bottle contains enough chemical for a typical system with a 14.5Kw Boiler (50,000 Btu/hr) domestic hot water cylinder and up to 10 radiators. For larger systems an extra bottle will be required - overdosing will not cause any problems or detrimental affects to the system.

Please note: where a thermal storage appliance is fitted allowance must be made for the extra volume of primary water. The concentration can be checked with a conductivity meter.

Limitations

Not suitable for use in PRIMATIC single feed cylinders. Only for use in fully indirect systems.

Container Size

1L plastic bottle.

Colour

Straw coloured liquid.

Shelf Life

24 months from date of manufacture when stored in original, sealed bottles.

Storage Conditions

Store in cool, dry conditions in tightly sealed container. Store above +5°C and below +30°C. Do not allow to freeze.

Disposal of Containers

Do not leave empty containers where residue could be harmful to children, animals or the environment. Replace lids and remove any containers to a central disposal point in accordance with local regulations.

Health & Safety

Please refer to separate material safety data sheet for full handling, use and storage instructions. Keep out of reach of children. It is the users responsibility to determine suitability for use. If in doubt contact our Technical Department for advice.

Note: this information is for general guidance only, since site conditions and labour are beyond our control. It is recommended that users make their own tests to determine suitability.
